### General information about practical exams

Centres must follow the guidance on science practical exams given in the Cambridge Handbook.

#### Safety

Supervisors must follow national and local regulations relating to safety and first aid.

Only those procedures described in the question paper should be attempted.

Supervisors must inform candidates that materials and apparatus used in the exam should be treated with caution. Suitable eye protection should be used where necessary.

The following hazard codes are used in these confidential instructions, where relevant:

Hazard data sheets relating to substances used in this exam should be available from your chemical supplier.

#### Before the exam

- The packets containing the question papers must **not** be opened before the exam.
- It is assumed that standard school laboratory facilities, as indicated in the *Guide to Planning Practical Science*, will be available.
- Spare materials and apparatus for the tasks set must be available for candidates, if required.

#### During the exam

- It must be made clear to candidates at the start of the exam that they may request spare materials and apparatus for the tasks set.
- Where specified, the supervisor must perform the experiments and record the results as instructed. This must be done out of sight of the candidates, using the same materials and apparatus as the candidates.
- Any assistance provided to candidates must be recorded in the supervisor's report.
- If any materials or apparatus need to be replaced, for example, in the event of breakage or loss, this must be recorded in the supervisor's report.

#### After the exam

- The supervisor must complete a report for each practical session held and each laboratory used.
- Each packet of scripts returned to Cambridge International must contain the following items:
  - the scripts of the candidates specified on the bar code label provided
  - the supervisor's results relevant to these candidates
  - the supervisor's reports relevant to these candidates
  - seating plans for each practical session, referring to each candidate by candidate number

## Specific information for this practical exam

#### Question 1

Each candidate should be provided with:

	1% glucose solution in a 100 cm <sup>3</sup> beaker labelled <b>U</b>	15 cm <sup>3</sup>
	Benedict's solution in a 100 cm <sup>3</sup> beaker labelled <b>Benedict's</b> solution	50 cm <sup>3</sup>
	empty 250 cm <sup>3</sup> beaker labelled water-bath	1
	small test-tubes (approximately 125mm × 15mm)	6
	test-tube rack to hold small test-tubes	1
	a supply of hot water at 80 °C	100 cm <sup>3</sup>
	Candidates will raise their hand when they are ready for hot water.	
	5 cm <sup>3</sup> syringe	3
	permanent marker pen	1
	stop-clock	1
	paper towels	5
	gloves	1 pair
	suitable eye protection	1

#### **Preparation of materials**

The glucose solutions may be prepared the day before the examination.

#### 2% glucose solution

 $150 \,\text{cm}^3$  of a 2% glucose solution can be prepared by adding 3g of glucose to  $150 \,\text{cm}^3$  of distilled water. This is enough solution for 5 candidates.

#### 1% glucose solution

150 cm<sup>3</sup> of a 1% glucose solution can be prepared by adding 1.5g of glucose to 150 cm<sup>3</sup> of distilled water. This is enough solution for 10 candidates.

#### Benedict's solution

Qualitative Benedict's solution for use in food tests is suitable.

Each candidate should be provided with:
