

General information about practical exams

Centres must follow the guidance on science practical exams given in the Cambridge Handbook.

Safety

Supervisors must follow national and local regulations relating to safety and first aid.

Only those procedures described in the question paper should be attempted.

Supervisors must inform candidates that materials and apparatus used in the exam should be treated with caution. Suitable eye protection should be used where necessary.

Hazard data sheets relating to substances used in this exam should be available from your chemical supplier.

Before the exam

- The packets containing the question papers must **not** be opened before the exam.
- It is assumed that standard school laboratory facilities, as indicated in the *Guide to Planning Practical Science*, will be available.
- Spare materials and apparatus for the tasks set must be available for candidates, if required.

During the exam

- It must be made clear to candidates at the start of the exam that they may request spare materials and apparatus for the tasks set.
- Where specified, the supervisor must perform the experiments and record the results as instructed.
 This must be done out of sight of the candidates, using the same materials and apparatus as the candidates.
- Any assistance provided to candidates must be recorded in the supervisor's report.
- If any materials or apparatus need to be replaced, for example, in the event of breakage or loss, this must be recorded in the supervisor's report.

After the exam

- The supervisor must complete a report for each practical session held and each laboratory used.
- Each packet of scripts returned to Cambridge International must contain the following items:
 - the scripts of the candidates specified on the bar code label provided
 - the supervisor's results relevant to these candidates
 - the supervisor's reports relevant to these candidates
 - seating plans for each practical session, referring to each candidate by candidate number
 - the attendance register.

Specific information for this practical exam

During the exam, the supervisor (**not** the invigilator) must do all the experiments and record the results on a spare copy of the question paper, clearly labelled 'supervisor's results'.

If chemicals are prepared in more than one batch, clearly labelled supervisor's results must be provided for each batch. The candidates using each batch must be listed on the supervisor's report.

- 2 × teat/dropping pipette
- 1 × spatula
- 1 × crucible with lid (approximate capacity 15 cm³)
- 1 × crucible tongs
- 1 × pipe-clay triangle
- $1 \times \text{tripod}$
- 1 × Bunsen burner
- 1 × heat-proof mat
- 1 × test-tube holder
- 1 × boiling tube
- 8 × test-tube*
- 1 × test-tube rack

balance, single-pan, direct reading, minimum accuracy 0.01 g (1 per 8-12 candidates) weighing to 200 g

- 1 × wash bottle containing distilled water
- 1 × pen for labelling glassware

paper towels

red and blue litmus papers

aluminium foil

wooden splints

the apparatus normally used in the centre for use with limewater in testing for carbon dioxide

* Candidates are expected to rinse and reuse test-tubes and boiling tubes where possible. Additional tubes should be available.

Where balance provision is limited, some candidates should be instructed to start the exam with different questions.

Materials

materials

The materials listed in the table must be provided to each candidate. Materials must be labelled only as specified in the 'label' column. The jidentities of chemicals labelled with letter codes, e.g. FA 1, may be different from their descriptions in the question paper. For example, candidates may be supplied with sulfuric acid, labelled as FA 1, but be told in the question paper that FA 1 is phosphoric acid.

FA 1	2.0g	hydrated aluminium potassium sulfate	Provide 1.8–2.2g of $A^{I}K(SO_4)_2 \bullet 12H_2O$ in a stoppered container. This substance is also called potassium alum.
FA 2	120 cm ³	0.0886 moldm ⁻³ sodium thiosulfate	Dissolve 22.00g of $Na_2S_2O_3 \bullet 5H_2O$ in each dm^3 of solution. Alternatively, dissolve 14.02g of $Na_2S_2O_3$ in each dm^3 of solution.
FA 3	120 cm ³	0.0175 mol dm ⁻³ potassium manganate(VII)	Dissolve 2.77 g of KMnO $_4$ [O][HH][N] in each dm 3 of solution.
FA 4	60 cm ³	0.50 mol dm ⁻³ potassium iodide	Dissolve 83.0g of KI in each dm³ of solution.
FA 5 [MH]	100 cm ³	1.0 mol dm ⁻³ sulfuric acid	See preparation instructions in the current syllabus.
FA 6	10 cm ³	starch solution	See preparation instructions in the current syllabus.
FA 7	20 cm ³	acidified 0.2 mol dm ⁻³ ammonium iron(III) sulfate	Mix 96.4g of NH ₄ Fe(SO ₄) ₂ •12H ₂ O [MH] with $100\mathrm{cm}^3$ of FA 5 [MH]. Add water to make up to $1.0\mathrm{dm}^3$. Alternatively, mix $53.2\mathrm{g}$ of NH ₄ Fe(SO ₄) ₂ [MH] with $100\mathrm{cm}^3$ of FA 5 [MH]. Add water to make up to $1.0\mathrm{dm}^3$.
sodium sulfite [C][MH]	5 cm ³	0.50 mol dm ⁻³ sodium sulfite	Dissolve 63.0 g of Na ₂ SO ₃ [C][MH] in each dm ³ of solution. Alternatively, dissolve 126 g of Na ₂ SO ₃ •7H ₂ O [C][MH] in each dm ³ of solution. This solution should be made up as close to the time of the examination as possible.
hydrogen peroxide	5cm ³	5 vol hydrogen peroxide	Dilute $250\mathrm{cm}^3$ of 20 vol $\mathrm{H_2O_2}$ [MH] to $1\mathrm{dm}^3$. Alternatively, dilute $50\mathrm{cm}^3$ of 100 vol $\mathrm{H_2O_2}$ [C] to $1\mathrm{dm}^3$. Supply in a stoppered container.
magnesium [F]	two 1 cm strips	magnesium ribbon	The ribbon should be lightly sanded before cutting.
zinc [F][N]	1.0g	zinc powder	Provide 1.0±0.1 g of zinc powder [F][N] in a stoppered container.

All solutions must be thoroughly mixed.
