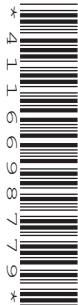

## General information about practical exams

Centres must follow the guidance on science practical exams given in the *Cambridge Handbook*.

### Safety

Supervisors must follow national and local regulations relating to safety and first aid.

Only those procedures described in the question paper should be attempted.

Supervisors must inform candidates that materials and apparatus used in the exam should be treated with caution. Suitable eye protection should be used where necessary.

### Before the exam

- The packets containing the question papers must **not** be opened before the exam.
- It is assumed that standard school laboratory facilities, as indicated in the *Guide to Planning Practical Science*, will be available.
- Spare materials and apparatus for the tasks set must be available for candidates, if required.

### During the exam

- It must be made clear to candidates at the start of the exam that they may request spare materials and apparatus for the tasks set.
- Where specified, the supervisor **must** perform the experiments and record the results as instructed. This must be done **out of sight** of the candidates, using the same materials and apparatus as the candidates.
- Any assistance provided to candidates must be recorded in the supervisor's report.
- If any materials or apparatus need to be replaced, for example, in the event of breakage or loss, this must be recorded in the supervisor's report.

### After the exam

- The supervisor must complete a report for each practical session held and each laboratory used.
- Each packet of scripts returned to Cambridge International must contain the following items:
  - the scripts of the candidates specified on the bar code label provided
  - the supervisor's results relevant to these candidates
  - the supervisor's reports relevant to these candidates
  - seating plans for each practical session, referring to each candidate by candidate number
  - the attendance register.

## Specific information for this practical exam

The supervisor must be a teacher of physics or other competent physicist who is familiar with the requirements of this syllabus. During the exam, the supervisor (**not** the invigilator) should obtain a sample set of numerical results by following the relevant steps in the question paper. The results should be clearly labelled 'supervisor's results' and recorded on the supervisor's report or on a spare copy of the question paper.

### Organisation of the exam

- The number of sets of apparatus provided for each experiment should be  $\frac{1}{2}N$ , where  $N$  is the number of candidates taking the exam.
- Candidates must **not** be provided with any additional apparatus beyond that specified in these instructions.
- Candidates should be allowed access to the apparatus for each experiment for one hour only.
- After spending one hour on one experiment, candidates should change over to the other experiment.
- The order in which a candidate attempts the two experiments is immaterial.

### Assistance to candidates

- Candidates should be informed that, if they find themselves in real difficulty, they may ask the supervisor for practical assistance, but that the extent of this assistance will be reported to the examiner, who may not award full credit for the relevant skills.
- Assistance should only be given when it is asked for by a candidate or where apparatus is seen to have developed a fault.
- Assistance should be restricted to enabling candidates to make observations and measurements. Observations and measurements must **not** be made for candidates, and no help should be given with data analysis or evaluation.
- In cases of faulty apparatus that prevent the required measurements from being taken, the supervisor should allow extra time to give the candidate a fair opportunity to perform the experiment as if the fault had not been present.
- Any assistance or extra time given to candidates must be recorded in the supervisor's report.

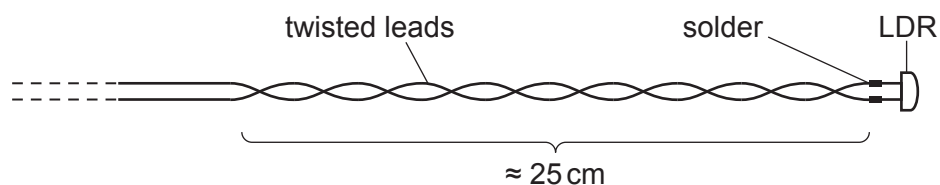
**Materials and apparatus for Question 1 (per set of apparatus unless otherwise specified)**

- 1.5V cell in a holder with terminals.
- NORPS-12 light-dependent resistor (e.g. [www.selectschoolsupplies.co.uk](http://www.selectschoolsupplies.co.uk) stock number 850-200). See Note 1.
- Two connecting leads, each of length 40 cm. See Note 1.
- Resistor of resistance  $1\text{ k}\Omega$  with a minimum power rating of  $0.25\text{ W}$  (e.g. RS Components stock number 707-7666), fitted with terminals for connecting leads.
- Switch.
- Small roll of opaque adhesive tape (e.g. electrical insulation tape).
- Scissors.
- Digital ammeter with a range of  $0\text{--}2\text{ mA}$  reading to  $0.001\text{ mA}$  or digital ammeter with a range of  $0\text{--}20\text{ mA}$  reading to  $0.01\text{ mA}$ . A multimeter set to one of these ranges is suitable provided the range switch is fixed and any unused terminals are covered.
- Strong cardboard tube of length  $22\text{ cm}$  and internal diameter  $2\text{ cm} \pm 0.5\text{ cm}$ .
- Four additional connecting leads.
- 30 cm ruler with a millimetre scale.

**Notes**

- 1 The two leads of length 40 cm should be soldered to the LDR terminals. The other end of each lead should be fitted with a normal lead connector.

The leads should be twisted together for approximately the first 25 cm from the LDR as shown in Fig. 1.1. If necessary they can also be taped together using transparent adhesive tape (e.g. Sellotape) over the 25 cm length.

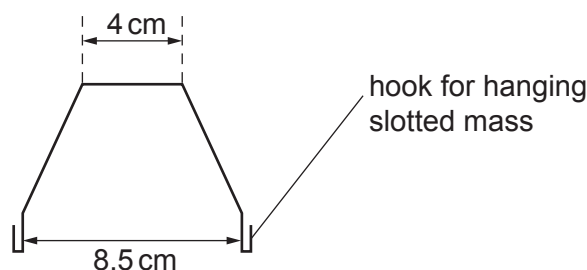
- 2 The apparatus should be laid out on the bench. If the apparatus is to be used by another candidate, then it should be dismantled and restored to its original state. Any used opaque adhesive tape should be removed.

**Materials and apparatus for Question 2 (per set of apparatus unless otherwise specified)**

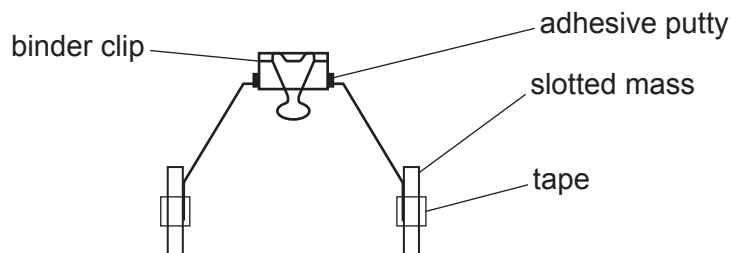
- Stand, boss and clamp.
- Steel wire of approximate diameter 1.6 mm and length 16 cm. See Note 1.
- Two binder clips of the style shown in Fig. 2.2 and with approximate width 20 mm. See Note 2.
- 0.3 g of adhesive putty. See Note 2.
- Two 20 g slotted masses. See Note 2 and Note 3.
- Solid silicone rubber cord of diameter 3.0 mm and length 15 cm (e.g. the 3 mm cord at <https://tym.co.uk/products/silicone-rubber-cord-white-60-shore>).
- Solid silicone rubber cord of diameter 4.0 mm and length 30 cm (e.g. the 4 mm cord at <https://tym.co.uk/products/silicone-rubber-cord-white-60-shore>).
- Stop-watch reading to 0.1 s or better.
- Vernier or digital calipers (may be shared between, at most, two candidates).
- 30 cm ruler with a millimetre scale.
- Metre rule with a millimetre scale.

**Notes**

- 1 Bend the wire into the shape shown in Fig. 2.1.

- 2 Tape the slotted masses onto the two hooks.  
Fix the wire inside one of the binder clips using the adhesive putty, as shown in Fig. 2.2.  
The other binder clip should be placed on the bench.

- 3 If 20 g slotted masses are not available, then two 10 g masses on each hook may be used.
- 4 The apparatus should be laid out on the bench. If the apparatus is to be used by another candidate, then it should be restored to its original state.
