Answer Question 1.

Research methods

- 1 Read Source A and then answer the questions below.

Source A

Table 1.1 shows the percentages of people who participate in different types of internet activity. The table shows statistics from five selected countries. In 2024 the World Bank did a large-scale online questionnaire on types of internet activity. The sample was made up of people aged 18-65. The statistics in Table 1.1 have been adapted from the primary data collected by the World Bank.

Table 1.1 Internet activities of individuals, by country

Type of internet activity	Germany	Zimbabwe	United Arab Emirates	Mauritius	India
Use internet banking	93%	32%	90%	52%	26%
Make voice calls	66%	28%	74%	40%	35%
Read books, newspapers and magazines	70%	26%	66%	39%	39%
Buy goods or services	83%	25%	79%	56%	46%
Take an educational course	19%	20%	23%	22%	18%
Watch TV and movies and play games	85%	32%	80%	62%	61%
Use social networks	90%	38%	88%	64%	82%

- (iii) Using information in **Source A**, explain **three** problems with the research for understanding people's internet activity. [6]
- (b) Give **two** examples of personal documents. [2]
- (c) Explain **one** strength and **one** limitation of quota sampling. [4]

- (d) Evaluate the interpretivist view that it is important for a researcher to achieve verstehen in sociological research.

- at least **two** arguments for and **two** arguments against
- a conclusion.
