General information about practical exams

Centres must follow the guidance on science practical exams given in the *Cambridge Handbook*.

Safety

Supervisors must follow national and local regulations relating to safety and first aid.

Only those procedures described in the question paper should be attempted.

Supervisors must inform candidates that materials and apparatus used in the exam should be treated with caution. Suitable eye protection should be used where necessary.

Hazard data sheets relating to substances used in this exam should be available from your chemical supplier.

Before the exam

- The packets containing the question papers must **not** be opened before the exam.
- It is assumed that standard school laboratory facilities, as indicated in the *Guide to Planning Practical Science*, will be available.
- Spare materials and apparatus for the tasks set must be available for candidates, if required.

During the exam

- It must be made clear to candidates at the start of the exam that they may request spare materials and apparatus for the tasks set.
- Where specified, the supervisor **must** perform the experiments and record the results as instructed. This must be done **out of sight** of the candidates, using the same materials and apparatus as the candidates.
- Any assistance provided to candidates must be recorded in the supervisor's report.
- If any materials or apparatus need to be replaced, for example, in the event of breakage or loss, this must be recorded in the supervisor's report.

After the exam

- The supervisor must complete a report for each practical session held and each laboratory used.
- Each packet of scripts returned to Cambridge International must contain the following items:
 - the scripts of the candidates specified on the bar code label provided
 - the supervisor's results relevant to these candidates

Specific information for this practical exam

During the exam, the supervisor (**not** the invigilator) must do the experiment in Question 1 and record the results on a spare copy of the question paper, clearly labelled 'supervisor's results'.

Question 1

Each candidate should be provided with:

	white tile	1
	100 cm ³ beaker containing dye to a depth of 1 cm from the bottom of the beaker (approximately 25 cm ³), labelled dye	2
	250 cm ³ beaker containing ice-cold water to a depth of 2 cm from the bottom of the beaker (approximately 60 cm ³), labelled C	1
	empty 250 cm ³ beaker labelled W	1
	warm water at approximately 40–50 °C for beaker W Candidates will raise their hand when they are ready for warm water. When requested, add water to beaker W to a depth of approximately 2 cm.	approximately 60 cm ³
	thermometer, –10 °C to +110 °C, with 1 °C graduations	1
	stop-clock	1
	a knife or scalpel	1
	hand lens (at least ×6 magnification)	1
	permanent marker pen	1
	30 cm ruler with a mm scale (also needed for Question 2)	1
	paper towels	5
	suitable eye protection	1
	gloves	1 pair

Preparation of materials*celery stalks*

Fresh celery stalks (*Apium graveolens*) should be prepared on the day of the exam. Remove any leaves and cut the stalks to approximately 10 cm in length. The celery stalks should be presented to candidates on a white tile.

dye

A water-based dark food colouring is a suitable dye. The dye may be diluted but must be of a concentration strong enough to clearly stain the vascular bundles of a celery stalk.
