General information about practical exams

Centres must follow the guidance on science practical exams given in the *Cambridge Handbook*.

Safety

Supervisors must follow national and local regulations relating to safety and first aid.

Supervisors must inform candidates that materials and apparatus used in the exam should be treated with caution. Suitable eye protection should be used where necessary.

Hazard data sheets relating to substances used in this exam should be available from your chemical supplier.

Before the exam

- The packets containing the question papers must **not** be opened before the exam.
- It is assumed that standard school laboratory facilities, as indicated in the *Guide to Planning Practical Science*, will be available.
- Spare materials and apparatus for the tasks set must be available for candidates, if required.

During the exam

- It must be made clear to candidates at the start of the exam that they may request spare materials and apparatus for the tasks set.
- Where specified, the supervisor **must** perform the experiments and record the results as instructed. This must be done **out of sight** of the candidates, using the same materials and apparatus as the candidates.
- Any assistance provided to candidates must be recorded in the supervisor's report.
- If any materials or apparatus need to be replaced, for example, in the event of breakage or loss, this must be recorded in the supervisor's report.

After the exam

- The supervisor must complete a report for each practical session held and each laboratory used.
- Each packet of scripts returned to Cambridge International must contain the following items:
 - the scripts of the candidates specified on the bar code label provided
 - the supervisor's results relevant to these candidates

Question 1

Each candidate should be provided with:

	test-tube holder, for handling hot test-tubes	1

Question 3

Each candidate should be provided with:

hazard	materials and apparatus	quantity per candidate
	30 cm ruler with a mm scale	1

Preparation of materials*0.5% sucrose solution*

This is prepared by dissolving 0.5 g of sucrose in 80 cm³ of distilled water and then making up to 100 cm³ by adding more distilled water.

100% invertase extract

Prepare a yeast suspension on the day before the exam by adding 10 g of dried yeast to 100 cm³ of distilled water and mixing well. Cover the yeast suspension and leave it in a refrigerator overnight. The yeast cells will settle to the bottom of the beaker and the liquid that remains above the cells forms the supernatant which contains the invertase.

On the morning of the exam carefully pour the supernatant liquid into a clean beaker, try not to include the yeast cells which can be discarded. The supernatant liquid is the 100% invertase extract.

10% invertase extract

This is prepared by adding 90 cm³ of distilled water to 10 cm³ of the 100% invertase extract and mixing well.

Benedict's solution [MH]

A commercially prepared Benedict's solution that can be used for standard food tests is suitable.
